**SHAREHOLDER HEREBY AGREES TO:**

1. To pay a connection fee of \$945 (for a 5/8” meter) or \$1,145 (for a 1” meter)
2. To pay a refundable backflow deposit of \$500 (to be refunded upon inspection – visit [www.OMWC.us](http://www.OMWC.us) for requirements)
3. To pay all stock assessments, water assessments and other fees when the same shall be due, in the amount and according to the schedule determined by the Board of Trustees from time to time.
4. To abide by and obey all current and lawful rules and regulations and bylaws of OMWC now or hereafter adopted by the Board of Trustees. To have water service, to the residence identified above, discontinued in the event the Shareholder uses more water than the amount allocated to Shareholder by virtue of Shareholder’s interest in OMWC, as determined by OMWC or by failure to pay all stock assessments and other fees as they come due and to have service resumed upon payment of a fee for the resumption of service.
5. To pay all costs, including attorneys’ fees, incurred by OMWC throughout its efforts to collect any delinquent stock assessments and other fees or to enforce this contract or any of the current rules and regulations of OMWC.
6. Shareholder shall not serve nor allow to be served more than 0.45, 0.55, 0.65, or 1.00-acre feet from the water connection provided for herein without the prior written approval of OMWC.
7. Shareholder shall not obstruct in any way the ability of authorized OMWC personnel to gain access to the Shareholder’s meter box, water meter and remote readout for periodic reading, maintenance and inspection. The cost of removing any such obstructions may be charged to the Shareholder.
8. Shareholder acknowledges that the meter box and the contents therein (i.e., the yoke, curb stop, water meter and remote reading device) are the property of OMWC and that the Shareholder will be subject to any and all legal penalties pertaining thereto for tampering with or otherwise obstructing or interfering with the normal operation and maintenance of the water meter. Shareholder acknowledges it owns the water supply line(s) from the supply side of the yoke (located within the meter box) to the Shareholder’s points of use and is responsible for maintenance, repair and/or installation of said water supply lines.
9. Shareholder acknowledges receipt of **General Water Company Information and Information for New Connections** and the other instructions included in the connection packet and has read and understands the information contained therein.
10. SHAREHOLDER UNDERSTANDS THAT UPON ACCEPTANCE BY OQUIRRH MOUNTAIN WATER COMPANY, **THIS IS A BINDING CONTRACT.**
